IMPORTANT INFORMATION

For safety reasons, it is imperative that students **stay seated** on the school bus and may be denied transportation for not adhering to this stipulation. If a student fails to follow the direction of the driver, the driver may suspend the riding privileges of the student.

Riding the school bus is considered a privilege, not a right. We are a transportation service and as such are required to adhere to restrictions governing passenger compartment luggage as laid out in the Motor Vehicle and Commercial Vehicle Acts. As a result, there are certain items, which are **not allowed** on the bus. Some of these are: **skis, hockey sticks, baseball bats, skate boards, large school projects, large band instruments**, etc. Items coming onto the bus must be school related and small enough to fit in a child's backpack. The driver determines what is safe.

In extreme weather conditions, every effort will be made to provide transportation to and from school. Buses will endeavor to continue on schedule as long as it is safe to do so, considering the temperature, road conditions, etc. Should any runs be canceled or delayed, unless otherwise notified, **schools will remain open** with route(s) cancellation(s) notifications sent via the School District Facebook, and Bus Status by Rally <https://sd54.busstatus.ca/#> on the School District 54 website.

THE DRIVER IS IN CHARGE! INAPPROPRIATE BEHAVIOUR WILL NOT BE TOLERATED AND MAY LEAD TO LOSS OF TRANSPORTATION SERVICES FOR YOUR CHILD:

1. Follow directions the first time they are given.
2. Keep hands, body and other objects to yourself.
3. Talk quietly, using appropriate language.
4. Smoking, drugs, vaping and alcohol are prohibited.
5. Written permission is required for students to get off at stops other than their regular home to school stops. **Bus notes should go to the school and not to the bus driver.**
6. Unregistered students are not allowed on the bus.
